Notable Settlements & Verdicts

\$4,000,000

A truck driver in Delano, PA suffered failed back syndrome from getting rear-ended by a tractor-trailer driver, who was driving in poor weather conditions.

\$4,000,000

Our client was riding her motorcycle when she struck a pothole with her tire, causing her to lose control and impact a guardrail. Basch & Keegan held the State accountable for failing to maintain the roadway in a reasonably safe condition.

\$3,850,000

The firm represented a woman who had an elective thyroidectomy performed at an Albany-area hospital and suffered permanent brain damage and disability due to complications following the surgery. This substantial settlement will be used to pay for her medical services.

\$3,750,000

After a long and difficult battle, justice was obtained. Our client was a grandmother visiting a museum with her grandchildren. She tripped and fell on a ramp that led from one room to another within the museum.

\$3,300,000

Our client made numerous complaints to her landlord – who never made any repairs to the house that she was renting. Our client literally fell through the floor and her foot was injured.

\$2,500,000

A rusted propane tank delivered by the defendant in this case leaked gas into a basement window. This eventually caused an explosion that injured the homeowners and killed their son.

\$1,620,000

*Highest jury verdict in
Ulster County in 2022.*

Our client was injured when she slipped and fell on an icy, sloped surface in the parking lot of the apartment building where she was a tenant.

\$1,100,000

*Highest jury verdict in
Ulster County in 2021.*

A driver struck a pedestrian in a wheelchair, inflicting a head injury that caused a significant brain bleed which was not diagnosed until weeks later. Following emergency surgery, our client remained in a coma for three days. He was later hospitalized for two weeks and spent over two months in a rehabilitation facility.
