### Rising Malpractice and Negligence: Risk in Elderly Patient Falls and Bedsores

#### Falls on the Rise

700,000 - 1 million patients /residents fall each year

17,000 malpractice claims per year for Pressure Ulcers



In 2022, Joint Commission data revealed the highest number ever recorded for traumatic patient falls, and this trend continued in the first six months of 2023. For the year 2022, patient falls ranked #1 when it came to the most frequent Sentinel Event reviewed in healthcare settings - unnecessary medical mistakes that caused significant patient harm or death. The number of Sentinel Events reviewed for traumatic falls in 2022 increased by 250% over 2020 and 26% over 2021.

It has been estimated that about 50% of nursing home residents fall at least one time per year. Basch & Keegan has handled hundreds of fall down cases against nursing home facilities in the Hudson Valley.

#### **Fall Prevention**

Medical research has revealed that many patient falls can be prevented with simple patient safety measures. The Joint Commission Center for Transforming Healthcare reduced falls with injuries by 62% in one study, simply by instituting common sense solutions, such as screening patients for fall risk on admission, providing education on fall prevention, having nurses and aides assist with bathroom visits, and hourly rounding to make sure patients are safe.

#### **Pressure Ulcers**

In the United States, more than 2.5 million patients suffer from pressure ulcers in any given year. And approximately 60,000 deaths a year are related to pressure ulcers. The cost of an ulcer ranges between \$20,000 and \$150,000; where the annual cost of these bed sores ranges between \$9 and \$16 billion. In addition, a University of Chicago report found that nursing home pressure ulcers were being under-reported, despite noting that approximately 41% to 54% of short stay nursing home residents suffered stage IV ulcers.

There is no doubt that a significant percentage of pressure ulcers develop in nursing homes, long term care and or rehabilitation facilities. Just this year, our firm has handled numerous bedsore claims against local establishments.

#### **Prevention of Pressure Ulcers**

There are many tools available for providers to avoid the development of pressure ulcers. High risk patients must be assessed and identified on admission. A complete and detailed initial skin examination is mandatory for high risk patients, and must be repeated on a frequent basis. Skin care and nutritional protocols need to be implemented, together with providing surfaces such as special mattresses to avoid mechanical pressure on fragile skin. At risk patients require frequent evaluation with risk assessment tools such as the Braden and or Norton Scales. These scales determine a patient's current risk of developing a pressure ulcer.
