New Office Safety Guidelines

Derek Spada Wins Appeal For Medical Malpractice Victim Basch & Keegan partner Derek Spada recently won an appeal for a victim of medical malpractice who was left blind in one eye following a botched eye surgery.

The victim sought treatment for a change in vision and a white spot in his eye from the defendant, an Albany-based ophthalmology practice.

The victim underwent a procedure known as a full thickness corneal transplant. Problems arose when the victim returned to the defendant's practice to have sutures removed from his eye. The transplant soon became infected, eventually causing the victim to suffer a retinal detachment and permanent loss of vision in his left eye.

When the victim initiated legal action against the ophthalmology practice, they responded by filing a motion to have his case dismissed. That motion was denied, but the ophthalmology practice appealed the decision.

Derek Spada fought the appeal and prevailed, ensuring the victim will have an opportunity to obtain compensation for his life-altering injuries and hold the doctors accountable for their actions.

Hudson Valley Court Proceedings Remain On Hold

When the Hudson Valley entered Phase Four of the state's reopening process, courts in Ulster County and surrounding counties officially resumed limited inperson appearances, which allowed for grand jury trials in criminal cases. Still, the timeline for resuming civil trials remains in question.

Governor Cuomo recently extended the executive order that temporarily suspends the statute of limitations for all civil cases until at least August 5th. Normally, the District Attorney has 6 months to prosecute a case, as the constitution grants the right to a speedy trial. Since juries cannot safely be impanelled during the pandemic, the right to a speedy trial must be temporarily suspended.

However, this does not mean that personal injury victims should wait to consult with an attorney. It is still important to begin investigating any possible negligence as soon as possible and to review the statute of limitations filing deadline with an attorney.

As Construction Resumes, Risk of Injury Remains A Concern

Construction work resumed in the Hudson Valley in May as the region entered Phase One of the state's reopening process, marking an important milestone in our return to normalcy.

Construction is critically important to our economy, but it often involves very dangerous work. The possibility of contracting COVID-19 on a job site adds another layer of peril to an occupation that already exposes workers to the risk of catastrophic injury or death.

According to OSHA, Out of the 4,779 worker fatalities in private industry in 2018, 1,008 (or roughly one in five) were in construction. The four leading causes of fatalities, sometimes referred to as the "fatal four" are:


Falls - 33.5% of fatalities

Being Struck by An Object - (11.1%)

Electrocution - (8.5%)

Caught Between Objects - (5.5%)
