

May is Motorcycle Safety Awareness Month



As the weather starts to warm up, you can always expect to see more motorcycles on the road, which is why May is the National Highway Traffic Safety Administration Motorcycle Safety Awareness Month.

Motorcycle crashes involving another motor vehicle account for nearly half of all motorcyclist fatalities in the United States. Motorcyclists are inherently at more risk

than motor vehicles because they lack many of the same safety features of automobiles. From a statistical perspective, motorcyclists are 27 times more likely to die in a crash than other motorists. Left-hand turns are the most common type of accident and accounts for 42% of accidents between a motorcycle and another vehicle.

If you drive a car, keep your eyes out for motorcycle riders and share the road. If you ride a motorcycle, observe your surroundings and be always careful when passing another vehicle. **Be smart, be safe, be seen.**


